■ Mail Buy-Back Service

Do you ever have any unused foreign currency notes or travelers cheques after returning from an overseas trip? Send your unused foreign currency banknotes and countersigned travelers cheques by registered mail to HSBC, and we will exchange them into Japanese Yen and credit the proceeds into a bank account of your choosing. *For amount less than JPY20,000(equivalent), a JPY500 service tariff is charged. **2% service charge is required for purchase of JPY travelers cheques.

■ Buy-Back cash in 32 currencies and travelers cheques in 7 major currencies listed below.

* The service is only available for banknotes and travelers cheques, **not for coinage**

DISCLAIMER

1. The customers who wish to sell foreign currency to HSBC must accept this terms and conditions and the disclaimer.
2. HSBC considers that a customer has applied for the buy-back service when the customer sends foreign currency and the application form with necessary information. HSBC buys foreign currency based on the application from the customer.
3. HSBC applies the HSBC cash buying rate for cash and HSBC T/C buying rate for T/C on the day the transaction is carried out. The converted JPY amount is transferred to the designated bank account in Japan.
4. If unlisted, outmoded, or heavily damaged notes are found, HSBC will send them back to the customer after making a telephone call.
5. Should the counterfeit notes be found, the case will be brought to the police immediately. In this case, the JPY amount corresponding the counterfeited notes will be deducted from the total amount.
6. If any discrepancies are found between the application form and actual amount of foreign currency sent to HSBC, the transaction will be carried out based on the actual amount.
7. The transaction is considered concluded when HSBC receives foreign currency and carries out the deal. No cancellation will be accepted after the completion of the transaction.
